Opinion

We have audited the calculation of the annual pension increase, effective January 1, 2021, for The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000, Unifor Local 5555 Members hired on or after May 1, 2010. The financial information has been prepared by management in accordance with Section 5.08(a) of The Plan text dated July 1, 2002, and subsequent approved amendments through to April 18, 2019.

In our opinion, the annual pension increase, effective January 1, 2021, of 1.34% for The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000, Unifor Local 5555 Members hired on or after May 1, 2010, is prepared, in all material respects, in accordance with Section 5.08(a) of The Plan text dated July 1, 2002, and subsequent approved amendments through to April 18, 2019.

Basis for Opinion
