Opinion

We have audited the calculation of the annual pension increase, effective January 1, 2020, for The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000 Unifor Local 5555 Members hired on or after May 1, 2010. The financial information has been prepared by management in accordance with the approved amendments to Section 5.08(a) of The Plan text dated July 1, 2002.

In our opinion, the annual pension increase, effective January 1, 2020, of 2.06% for The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000, Unifor Local 5555 Members hired on or after May 1, 2010, is prepared, in all material respects, in accordance with the approved amendments to Section 5.08(a) of The Plan text dated July 1, 2002.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the "Auditors' Responsibilities for the Audit of the Financial Statements" section of our auditors' report.

We are independent of The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000, Unifor Local 5555 Members hired on or after May 1, 2010, in accordance with the ethical requirements that are relevant to our audit of the Statement in Canada and we have fulfilled our other ethical responsibilities in accordance with these requirements.



We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management for the Statement

Management of the The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College and The Contributory Pension Plan for Salaried Employees of McMaster University, including McMaster Divinity College 2000, Unifor Local 5555 Members hired on or after May 1, 2010, is responsible for the preparation of the financial information in accordance with the approved amendments to Section 5.08(a) of The Plan text dated July 1, 2002, and for such internal control as management determines is necessary to enable the preparation of financial information that is free from material misstatement, whether due to fraud or error.
